## Australian Securities Exchange Announcement **CLARIFICATION – DIAMONDS NOT CONTAINED IN SA PROSPECT**

### **CLARIFICATION**

- *Additional analysis following announcement of diamonds in exploration samples on 26 June confirms that diamonds are not present.*
- *SEM analysis reveals diamond-like crystals were florencite – a hydrated rare earth aluminium phosphate.*

### **NON-CONFIRMATION OF DIAMONDS REPORTED ON 26 JUNE**

On 26 June, Flinders Mines Limited (Flinders) reported what it thought was a new diamond discovery from the Nackara Helimag survey in the area about 40 km northeast of Peterborough in South Australia. It was stated at the time that “Much work, including verification of the results, is necessary before the true significance of the discovery is known”. Additional analytical work has now been completed with the result that the original diamonds have not been confirmed. During SEM (secondary electron microscope) analysis the presence of: O, Al, P, Ce and La was measured semi-quantitatively and the unknown mineral was determined to be florencite  $(\text{Ce, La})\text{Al}_3(\text{PO}_4)_2(\text{OH})_6$ .

Two of the 10 grains thought to be diamonds are shown in Figure 1. The pseudo-cubic crystal shape of florencite can easily be confused with the common octahedral shape of diamonds. Flinders Diamonds Pty Ltd has put in place new procedures involving SEM analysis to avoid misidentification of diamonds in future. This will mean slight delays in reporting of diamond results while an independent check on the presence of diamond is carried out.

While the lack of verification of the presence of diamonds is disappointing, Flinders remains confident that it is exploring in a well mineralised province and that future discoveries of diamondiferous kimberlites remain likely.
